Meeting called to order 7:00

<u>Special report</u> – Darrin reported Skeet qualifications ended this past Sunday, netted 23 shooters. He states they have the light towers up and should be shooting skeet Wednesday evenings, check the web.

<u>Financial report</u> – Lisa reports as of 11/30/22 – checking \$111,634, savings \$335,326, total \$446,960, less: dedicated fund \$154,477, less: club house restriction \$139,778, less: funds set aside for land \$33,964, cash available \$118,741, fixed costs \$147,682, expended year to date \$124,439, balance left to pay \$23,243, available disposable income \$83,498. She and Mike also reviewed a draft of the SFG 2023 BUDGET with the membership present. Motion was made to accept the 2023 budget, was seconded, no further discussion at that point, unanimously accepted.

<u>CRSO</u> – Don reported a lady had fallen in the parking lot and could not get up but had her phone with her and was able to call for help. Thank Goodness she was okay. Carl reminded members that this time of year what way appear to be water may be ice.

<u>Membership</u> - Heather reported no hardships, 1,160 active members in the database, 51 applicants, 10 first readings, 5 have sponsors, 35 awaiting interviews, 16 tomorrow night, 6 awaiting orientations.
