**Schedule and Location:** Scarborough Fish & Game Assoc., 79 Holmes Road, Scarborough, ME  
Thursdays 5:00 p.m. May 4 – September 28. Range opens at 4:30 p.m. for setup. Shooting starts at 5:00 p.m. Late comers are always welcome - we'll move you to the line as soon as we can.

### Directions:

Maine Turnpike to Exit 42. Take left off exit (Payne Rd). Make left at next light (Holmes Rd). You will see Beech Ridge Speedway on your left, a large parking lot on your right. Turn right on the road at the end of the parking lot. You will see the Scarborough Fish & Game sign - right across from the speedway.

### Prerequisites:

You must have completed a SF&G bullseye pistol clinic or have a current NRA precision pistol classification card. Individuals under the age of 18 must be accompanied by an adult parent or guardian and remain under their direct supervision.

### Information:

We use .22 pistols only. Loaner guns are available. You must use our ammo if you use our pistols. Ammo is for sale at \$10.00 per box of 50. Eye and ear protection is mandatory for all participants.

**Course of Fire:** repeating NRA Short Course - 3 or 4 per session depending on daylight or .22 caliber only 900.

**Fee:** Season rate \$30.00 Drop-in rate \$4.00 per week

First round goes down range at 5 p.m. The range will be available 30 minutes prior for setup and preparation. Come early and be ready to shoot. Late comers are welcome. Squad formation is by infiltration. See the Chief Range Officer upon arrival.
