The Gun Control Act (GCA), codified at 18 U.S.C. § 922(g), makes it unlawful for certain categories of persons to ship, transport, receive, or possess firearms or ammunition, to include any person:

- *convicted in any court of a crime punishable by imprisonment for a term exceeding one year;*
- *who is a fugitive from justice;*
- *who is an unlawful user of or addicted to any controlled substance (as defined in section 102 of the Controlled Substances Act, codified at 21 U.S.C. § 802 This **includes medical or recreational marijuana**);*
- *who has been adjudicated as a mental defective or has been committed to any mental institution;*
- *who is an illegal alien;*
- *who has been discharged from the Armed Forces under dishonorable conditions;*
- *who has renounced his or her United States citizenship;*
- *who is subject to a court order restraining the person from harassing, stalking, or threatening an intimate partner or child of the intimate partner; or*
- *who has been convicted of a misdemeanor crime of domestic violence.*

The GCA at 18 U.S.C. § 922(n) also makes it unlawful for any person under indictment for a crime punishable by imprisonment for a term exceeding one year to ship, transport, or receive firearms or ammunition. Further, the GCA at 18 U.S.C. § 922(d) makes it unlawful to sell or otherwise dispose of firearms or ammunition to any person who is prohibited from shipping, transporting, receiving, or possessing firearms or ammunition.

**Release Agreement:** Intending that this agreement be legally binding upon me, my heirs, executors, administrators, and assigns, I hereby waive, release, and forever discharge Scarborough Fish & Game Association, and all of their instructors, representatives, heirs, executors, administrators, successors, and assigns, of and from any and all claims, demands, rights and causes of action of whatsoever kind and nature, arising from, and by reason of any and all known and unknown, foreseen and unforeseen physical and mental injuries and consequences thereof, suffered by me during any and all training courses instructed or hosted by Scarborough Fish & Game Association.

**By my signature, I certify that the above GCA 18 U.S.C. § 922(g) unlawful categories do not apply to me, therefore I am not prohibited from possessing or using a firearm and/or ammunition AND agree to the terms of the Release Agreement.**
